Between 5 and 163 on Interstate 8 – Exit Hotel Circle Drive from either direction on I-8

#### From I- 8 West and 163 South

- Exit Hotel Circle
- At stop sign make a Right onto Hotel Circle No
- Go under the overpass go right onto Hotel Circle So
- Make a left into first driveway on the left
- If you reach Bachman Place you went too far

#### From 163 North

- Exit I-8 West to Hotel Circle
- Follow above Directions

#### From I-8 East

- Exit Hotel Circle
- Make Left onto Hotel Circle So
- Go to end just before left turn
- Make right turn into the driveway
- If you go under overpass you went too far
